Summary

- Working experience of teaching and research in premier universities and colleges in India for over thirty five years. After more than ten years of teaching in Hindu College, and about five years of teaching in Panjab University, Chandigarh, have served for almost seventeen years in Delhi University. In the course of these years of teaching, have contributed to framing of new courses, restructuring of teaching programmes, examination process, and supervision of research students. It is gratifying that the PhD thesis of four of my research students was eventually published as books from the reputed Oxford University Press and one from Vani Prakshan.
- Have taught core courses in Indian Politics and Comparative Politics and a range of optional courses in the Masters and Research Programme. My optional courses in Masters and at the MPhil and PhD levels reflect my research concerns in the field of state, law and politics in India, state and constitutionalism in a comparative perspective, law and politics, and political institutions and democracy. All these courses are designed to enable students to engage with critical concepts and develop an understanding of how these concepts may be operationalised. The objective in all the courses is to instill curiosity in students and rigour in comprehending social and political realities.
- My research has traversed some key areas in the study of Indian politics, including political institutions and state and democracy in India. My first book on Political Prisoners in India, published by Oxford University Press, emerged out of my PhD thesis written in SOAS, University of London. It examines the criticality prisons and jail-going assumed in the anticolonial movement and in post-colonial India, through an examination of prison memoirs and official documents. Subsequently, my book on Anti-terror laws, published by Sage, explores the trajectory of laws that address terrorism in India. My most recent book on the Election Commission of India, published by Oxford University Press, is a political anthropology of one of the most significant institution of the country. A co-authored edited book on Legal Literacy, also published by the Oxford University Press, was among the foremost efforts made by Delhi University to bring together teaching programmes and academic research. The royalty from the sale of the book is received by Delhi University.
- Have published consistently in research journals which are reputed, peer reviewed or scopus indexed. Some of these journals are Territory, Politics and Governance, Diogenes, Scienza and Politica, Critical Asian Studies, Journal of Policing, Intelligence and Counter Terrorism, Asian Studies Review, Election Law Journal, Studies in Indian Politics and Economic and Political Weekly all of which are known for the rigour in publication process, and wide readership.
- I strongly believe that institutions matter and as an academic one must continually strive to strengthen them. I have participated in the institutional life of the University of Delhi and served on whatever position of responsibility I was appointed as member of various

governing bodies of colleges and research councils of faculties and departments, and presently as the Dean Research (Humanities and of Social Sciences), a position that I have held for almost three years now.
